What is exploitation?

Collection and use of amphibians for

- Consumption (subsistence vs. commercial)
- · Pet trade
- Research
- · Traditional medicine

How exploitation kills amphibians

- Direct removal of individuals from the wild
- Indirect effects (will come back to this)



Evidence of declines

France

- Large numbers of harvested frogs
- Population declines
- Led to prohibition of collection, trade, and sale of native frogs



Evidence of declines

India and Bangladesh

- · Formerly major frog leg exporters
- Population declines due to exploitation led to halt of exportation of frogs

Importance of exploitation

Indirect effects of exploitation

- Pathogen pollution- chytrid and ranavirus
- Release of nonnative species
- Pesticides: cascading effects of amphibian exploitation

Importance of exploitation

Magnitude of the issue

- 5 million live amphibians were traded internationally in 2006 for pets or human consumption.
- Utilization of amphibians represents a threat for 281 species, according to IUCN.

So what can be done?

- · Improvement of regulations
- Certification and monitoring
- Better enforcement to prevent illegal trade
- Prevention of disease and invasions is the best option
- · Captive breeding?
 - Not a good solution: risk of species invasions, disease
 - Most attempts have failed
- Educating consumers

So what can be done?
